### Executive Summary

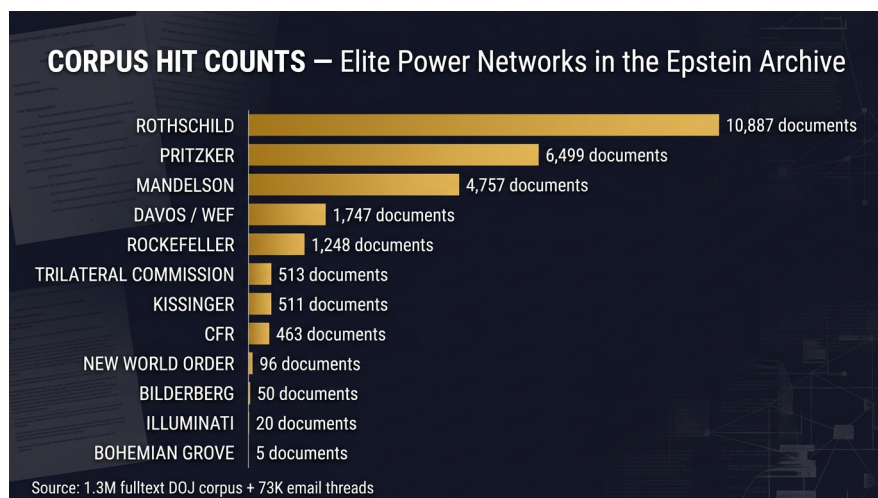
Jeffrey Epstein was not merely adjacent to elite power networks — he was a **formal, documented member** of two of the most consequential organizations in global governance: the **Trilateral Commission** and the **Council on Foreign Relations**. He sat on the board of **Rockefeller University**. He maintained direct, ongoing financial and personal relationships with **multiple branches of the Rothschild family**, served as a conduit between **Kissinger, Bilderberg** attendees, **Davos** elites, and heads of state. His own correspondence uses explicit “secret society” and “inner circle” language to describe his network.

The corpus contains **10,887 documents** mentioning Rothschild, **513** mentioning the Trilateral Commission, **511** mentioning Kissinger, **463** mentioning the Council on Foreign Relations, **50** mentioning Bilderberg, and **1,747** mentioning Davos. This is not conspiracy theory — it is the documentary record of a man who operated as a **human router** between the world’s most powerful institutions and families.

## Part I: Epstein's Formal Memberships

### *Trilateral Commission — Confirmed Member*

Epstein's membership is confirmed by **five independent sources** in the corpus:

**1. Official Biography (EFTA00725190)** > “Jeffrey E. Epstein is the Chairman of Financial Trust Company, Inc. Mr. Epstein is a former member of the **Trilateral Commission** and a former member of the **Council on Foreign Relations.**”

This bio appears in at least **8 EFTA documents** with minor variations (EFTA00725191, EFTA00295224, EFTA01149235, EFTA00304519, EFTA01107374, EFTA00583240, EFTA01131064, EFTA01146347).

**2. Trilateral Commission Plenary Invitation (2008)** Lesley Groff forwarded an official invitation from **Michael O'Neil** (moneil@trilateral.org) to the **2008 Trilateral Commission Plenary Meeting**, April 25-28, Ritz Carlton, Washington DC. Epstein was addressed as a “Member and Participant.”

**3. Full TC Membership Roster (EFTA01082667)** A document in the Epstein files contains the complete **Trilateral Commission North American Group** membership list. Epstein is listed:

To Steve Bannon (May 8, 2018 — EFTA00813315): > “when I was on the trilateral commission. I always took along my very pretty american looking california blonde assistant that was silently fluent in the three main dialects. I loved it when they smiled to me as they said to each other . be careful of the Jewish dog.”

To unknown (Feb 22, 2017 — EFTA01053658): > “He is the most knowledgeable of all the players I have known. - including my stint on the Trilateral Commission.” (*Referring to Ehud Barak*)

To unknown “Khalid” (Oct 29, 2016 — EFTA00813539): > “Khalid, great fun today, . trilateral commission. ? alberto pinto. ? ... see you in Saudi.”

Via iMessage (Mar 29, 2017 — HOUSE\_OVERSIGHT\_027222): > “as you may know I used to be a member of the trilateral commission. so i have some strong views on benefits and burdens of the various orgs.”

**5. COUQ Foundation Payment (EFTA00804104)** Check #2373, dated October 1, 2006: **\$50,000 to “The Trilateral Commission”** from the COUQ Foundation.

***Ghislaine Maxwell — Independent TC Attendee***

Ghislaine Maxwell to Lars Erickson (2002): > “Functions? Will there be any cute guys present other than you? I’m coming in for the **Trilateral meetings**. E mail me your no. so I can call you and we can coordinate some trouble”

***Council on Foreign Relations — Confirmed Member***

Same bios confirm CFR membership. Active engagement documented:

- **Valerie Post** (CFR Director of Events) maintained a personal relationship with Epstein, with multiple phone dates and in-person meetings (EFTA02421956, EFTA02423409, EFTA00751793)
- Epstein offered to place “young people” as volunteers at CFR; Post confirmed CFR has “strict rules around interning” but offered “special consideration”
- Libyan President Magariaf’s CFR luncheon invitation forwarded to Epstein (EFTA00635170)

***Rockefeller University — Former Board Member***

Confirmed in multiple bios. Also: - Martin Nowak sent Epstein a Rockefeller University research link (EFTA02006721) - George Church conference at Rockefeller University in Epstein’s calendar - A victim reportedly flew on a “Dana Chasin (Rockefeller) plane” (dossier #24679, NUCLEAR tier)

***The COUQ Foundation — “Personal Genomics and Power”***

Epstein’s bio describes the COUQ Foundation (EFTA00725190) as: > “one of the largest scientific philanthropies, funding topics such as ‘**Biologically Inspired Financial Computing,**’ ‘**Game Theory and the Currency Markets,**’ ‘**The Mathematics and Political Impacts of Esoteric Financial Instruments,**’ and ‘**Personal Genomics and Power.**”

The 2006 COUQ ledger (EFTA00804104) shows \$958,000 disbursed, including: - \$100,000 — President and Fellows of Harvard College - \$75,000 — Santa Fe Institute (Murray Gell-Mann Research) - \$50,000 — The Trilateral Commission - \$25,000 — William J. Clinton Foundation - \$25,000 — Stockholm School of Economics - \$100,000 — Institute of International Education

### *The Rothschild Name Dispute (EFTA00845317, EFTA00845468, EFTA00845910)*

In September 2015, **Jacob Rothschild** drafted a letter to David and Eric de Rothschild (French branch) objecting to Paris Orleans renaming itself “Rothschild & Co” without a distinguishing prefix. **Epstein was personally advising Ariane de Rothschild on the wording**, suggesting: > “inflict damage? could be better worded”

### *Brokering Summers for Rothschild (Dossier #25507)*

Epstein recommended: > “take larry summers on in a sig role...good press, stature”

Summers subsequently met with Ariane de Rothschild at Epstein’s house alongside his wife (dossier #24306).

### *Trump and Rothschild (HOUSE\_OVERSIGHT\_026431)*

After Ariane pitched Epstein on Edmond de Rothschild’s infrastructure fund, Epstein replied: > “trump will want to do private public partnerships on most things. **donald loves the rothschild name.**”

**Lynn Forester de Rothschild — The Social Bridge**

Lynn Forester is one of the most consequential figures in Epstein's network:

- **1995:** Discussed “Jeffrey Epstein and currency stabilization” with **Bill Clinton** (EFTA00263405)
- **July 1996:** Called Dershowitz on Martha's Vineyard: “A FRIEND OF HERS NAMED JEFFREY EPSTEIN HAD FLOWN TO MARTHA'S VINEYARD TO VISIT HER AND THAT HE WOULD LIKE TO DROP BY AND MEET ME” (EFTA00796700)
- **2000:** Sold **116 East 65th Street** to Ghislaine Maxwell's **116 East 65th Street LLC** for \$4,950,000 (EFTA01654636) — property later sold for \$15,075,000
- Peter Mandelson: “I think it was Martha's, the first time I met Jeffrey, **staying with Lynn Forester...**” (EFTA00703220)
- Epstein leaked to journalist Landon Thomas (2010): “Lady rothschild, Lynn forester, ex husband Andrew Stein and her financial advisor Kenneth Starr, indicted for another big ponzi scheme” (EFTA01811978)

**The “Master Name List” (Dossier #24407)**

Epstein's own shorthand for his power network: > “bannon chomsky barak watson **rothschild** black pritzker summers ito. World bank davos g20”

**Part III: The Bilderberg Connection**

**50 documents. All roads lead through Peter Mandelson.**

**Mandelson at Bilderberg — Epstein as Logistics Coordinator**

**June 2011** — Mandelson to Epstein (EFTA01863211): > “St moritz at **bilderberg** with your friend from norway” (*The “friend from Norway” is likely Crown Prince Haakon, whose wife Crown Princess Mette-Marit appears in the persons directory*)

**April 2012** — Mandelson to Epstein (EFTA00660427): > “Should be coming from Toronto around weekend May 27 **til Bilderberg the following weekend in Virginia.**”

**June 2012** — Mandelson to Epstein (EFTA02555795): > Subject: “Inequality” > “now been put firmly on **Bilderberg agenda...**”

**May 2010** — Unknown (likely Mandelson) to Epstein (EFTA00753966): > “Is Tim Collins of Ripplewood ok guy? Apart from talking about himself all the time. **He has offered to pick me up en route to Bilderberg in plane.**”

Epstein replied: “he is good friends with Jes [Staley], little full of himself good white house contacts.”

***The Mandelson-Epstein Relationship (4,757 documents)***

Peter Mandelson (Baron Mandelson, former Labour cabinet minister, EU Trade Commissioner) maintained one of the most prolific correspondences in the Epstein archive: - Regular visits to Epstein's properties - Discussed Russian oligarchs ("Nat does not want me to meet Oleg" — EFTA00878060) - "Need a Lord on the board?" — Mandelson offering his title (EFTA00924203) - Met Epstein through Lynn Forester de Rothschild at Martha's Vineyard

- Multiple calendar reminders: "**Kissinger is free starting evening of Sept. 23rd**" (EFTA02127216, repeated across 6+ documents)
- Guest lists: "sean parker, terje, marvin, axel. **kissinger**, ian. miller, abdullah, don deitsch lara lerner" (EFTA00428822)
- Epstein to unknown: "**does bill know kissinger well?**" (likely re: Gates or Clinton)
- **Kissinger + Rothschild breakfasts**: Epstein to Ehud Barak: "can you do breakfast with ariane rothschild on morning of 23. and if you want **kissinger china guy at breakfast 24.**" Barak confirmed, adding "I have Clinton GI on 9am."

***Kissinger China NewCo (EFTA00584255)***

A full business plan for **Kissinger China NewCo (KCN)** was found in Epstein's files: - Henry Kissinger as Executive Chairman - Joshua Ramo as Chairman/CEO - Profit distributions: 50% to Kissinger in year one, declining to 10% by year five - Goal: "the leading advisory firm on China-related commercial matters"

***Pritzker-Kissinger-Epstein Triangle***

Tom Pritzker (Chairman of CSIS, Hyatt heir) to Epstein: > "In NY now (P Prize jury). Next week in Davos. **Kissinger is flying w me** and got a message from ehud that he will be there."

Epstein advising someone (HOUSE\_OVERSIGHT\_027222): > "**Tom Pritzker. - like family,** : the chairman of CSIS. also pritzker prize and trekking in himalayas. probably worth a meeting for you"

***The Power Dinner (Dossier #25538)***

Lesley Groff's guest list for a single dinner: > Terje Rod-Larsen, **Leon Black, Ehud Barak, Geithner, Jes Staley, Lloyd Blankfein, Len Blavatnik, Larry Summers, David Blaine, Ja-**

**cob Frankel, Woody Allen, Checky, JJ Abrams, Schwarzman, Kissinger****Part V: The Bohemian Grove****5 documents. Limited but direct.*****Epstein to Morits Skaugen (EFTA00938322, July 8, 2012)***

Skaugen (Norwegian shipping magnate, CEO of IM Skaugen SE) wrote: > “Greetings from singapore; **on my way to California and to try to understand about the people at the Bohemian Grove**”

Epstein’s reply discussed Karem Wade (son of Senegal’s former president, former energy minister).

***House Oversight — Cathy O’Brien Testimony (HOUSE\_OVERSIGHT\_015259)***

The corpus contains Cathy O’Brien’s allegations about **mind control at Bohemian Grove** involving Bill and Bob Bennett, referenced alongside NASA’s Goddard Space Flight Center. This document was part of the House Oversight collection, not Epstein’s personal correspondence.

## Part VI: “Secret Society” and “Inner Circle” Language

### *Epstein Used These Terms Himself*

“**Part secret society**” — A profile piece (attributed to Michael Wolff, 2016) circulated by Epstein describes his operation: > “by careful design, exclusive and clubby, **part hang out, part secret society**”

The same profile on the Trilateral Commission: > “He joined the board of Rockefeller University. And then he was suddenly on the **Trilateral commission, that cabal of business people** who are fancied by some conspiracy buffs, as the group running the world.”

“**The Club**” / “**First Circle**” — Epstein to David Stern (former NBA Commissioner), dossier #524: > “You should meet Reid and tell him you are **part of the club**” > “Tell him you are a **friend of the first circle**”

This was the day before Stern dined at **Windsor Castle** with Prince Andrew.

“**Our Secret Society**” — Epstein to a Gates insider (dossier #22454, NUCLEAR tier): > “both are welcome to **our secret society**, they will join joi ito ed boyden and caleb”

“**Old School Secret Society**” — Inbound query to Epstein: > “Suggestions for an old guy. super smart / well connected that wants to **continue legacy of ‘old school’ secret society?**”

No reply found in the archive.

## Part VII: “New World Order”

96 documents. Epstein used the term himself.

### *Martin Nowak to Epstein (Aug 14-15, 2013)*

EFTA00678866 (Aug 14): > “that biology is not based on physics is a **new world order** and it is right”

EFTA00967086 (Aug 15): > “i just came back thank you so much for the beautiful time **creating a new world order...**”

### *Epstein’s Economic Prediction (Dec 2009 — EFTA02433799)*

Epstein to an unknown correspondent: > “a **new world order** commodity prices likely up, metals up, unemployment and the stock market up.”

Reply: “New world order? Markets up, but also unemployment?”

Epstein: “exactly, a little like brazil. this is an unintended consequence of computers and the internet.”

**1,747 fulltext hits. 355 email threads.**

- Gates scheduling through Epstein at Davos (dossier #11768)
  - Jes Staley's office brokered Gates-Epstein meeting at Davos (#11775)
  - Epstein invited **King Abdullah** to “bill gates dinner” at Davos (#13067)
  - Epstein got Summers nominated for **WEF Young Global Leader** (#25477) — Summers asked “Is she smart? Attractive?” then “She is very hot”
  - **“Davos set for you. Replace Mnuchin.”** — 3 weeks before arrest (#24556)
  - Pritzker flying with Kissinger to Davos

## Part IX: The Intelligence Dimension

### *Persons Categorized as “Intelligence” in the Directory*

Only 4 of 3,228 persons carry this tag: | Person | Category | |——|———| | **Robert Maxwell** | intelligence | | **Ari Ben-Menashe** | intelligence | | (2 others) | intelligence |

Robert Maxwell (Ghislaine's father) was alleged to have been a Mossad asset. Ari Ben-Menashe, a former Israeli military intelligence officer, has publicly claimed Maxwell worked for Israeli intelligence.

### *Trilateral Commission = Intelligence Community*

The TC member roster in EFTA01082667 includes **three former CIA Directors**: - **George J. Tenet** — CIA Director 1996-2004 - **John M. Deutch** — CIA Director 1995-1996 - **William H. Webster** — CIA Director 1987-1991 (also FBI Director 1978-1987)

### *Wexner Foundation □ Ehud Barak (EFTA01249848)*

An FBI/DOJ referral document states: > “ZADOK also stated that the **WEXNER FOUNDATION transferred at least 2.3 Million USD to Israeli former Prime Minister Ehud Barak; EPSTEIN allegedly signed some of these transfer documents.**”

### *Shadow Government Proposal*

Epstein proposed to Gates a “**shadow governmental grants structure**” (dossier #13492, NUCLEAR tier) — an off-book influence operation running parallel to the Gates Foundation.

## Part X: The Illuminati Families Document

### **EFTA01082667 — “Illuminati Families and Their Associates”**

This 8-page document (EFTA01082667-01082674) was found in Epstein’s files (DOJ Dataset 9). It is a **conspiracy theory compilation**, not Epstein’s own writing. However, its presence in his records is notable. It lists:

**The 13 “Illuminati Bloodlines”:** 1. The Astor Bloodline 2. The Bundy Bloodline 3. The Collins Bloodline 4. The DuPont Bloodline 5. The Freeman Bloodline 6. The Kennedy Bloodline 7. The Li Bloodline 8. The Onassis Bloodline 9. The Reynolds Bloodline 10. The Rockefeller Bloodline 11. The Rothschild Bloodline 12. The Russell Bloodline 13. The Van Duyn Bloodline

Plus: The Merovingian Bloodline, The Mormon Leadership, The Disney Bloodline, The Krupp Bloodline, The McDonald Bloodline

**Organizations referenced:** - Council On Foreign Relations - The Bilderberg Group - **The Majestic Project / MJ-12** - The Trilateral Commission - “Illuminati: Order of Illumined Wise Men” - “The Illuminati Formula to Create an Undetectable Total Mind Control Slave” - “The Biological Basis of Elitism and ‘The Divine Right’ Rule” - “The Rose and the Rosicrucians”

The same document contains a full **Trilateral Commission membership roster** — the one that lists Epstein himself.
